8.1. The Sewer, Festival, Gas Tax, Rink Renovation, and Municipal accounts have all been reconciled and balanced.

9.3. Ballfield Project updates. Pictures of the ballfield have been put up on social media and they look great. The ballfield lights at the Church ballfield must be purchased and installed. Winter is fast approaching, and MacEwan Electric will not likely be able to install the poles until spring. They need to purchase them and deliver them but will be looking for the payment in advance to purchase polls. There is no action item on this, its just to make Council aware.

9.4. Rink opening was delayed due to item that needs to be fixed. This is not in relation to Phase 3.

9.5. September Sewer Issue that affected NoraLynn Dunn's property

- 9.5.1. Action Item** – Municipal Office will look into the suggestion that Heather Sampson proposed of looking into a private septic system on NoraLynn Dunn's property to solve for septic issues.
- 9.6. Food Trucks** – Review insurance issues, Department of Transportation, and unsightly premises, and permits. More research will be done before any additional discussions or decisions will be made.

- 10.1.** Heat Pump Project for the Fire Hall received funding. Quotes were provided earlier in the year.
- 10.2. Action Item-** The Municipal Office will send provide the **3** quotes for review and recommendation before next meeting with the budget that is allocated.
- 10.3.** Municipal Affairs recommended setting the election date earlier than the 6 months, and ideally before the new year. It should be for both spaces if a Council member decides to run for Mayor.
- 10.4.** The Council needs to choose a date for the byelection, which has to be a Monday.

- 10.9.** Kyle McDonald lives on Red Head Road. The Kelly Green trail is a favorite spot of his entire family. Fiona did a large scale amount of damage to the park. He is proposing to work for the Municipality to clean up the park. The recommendation by Deputy Mayor Danny Kelly to Kyle is to create a proposal and provide costs associated with the work and present it to the council for a formal review.

- 10.10.** Heather Sampson will be away for a few weeks in November and recommends that we have an additional signing authority in place during that time.




